1. Clarification sought:

2. Clarification sought:

- On Instructions to Tenderers, page. 7, point (E) a Technical Specifications is required to submit the tenderer's Technical Offer ONLINE through the Tender Response Format and using the Tender Preparation tool provided: Where do I could find the Tender Response Format? and where is and how to use the Tender Preparation Tool?

Clarification reply:

Clause 7 Selection and Award Requirements, (C) Technical and Professional Ability, Clause 4 and Clause **(E) Technical Specifications (i) both** found on page 7 of the Instructions To Tenderers Should read:

Provide data concerning subcontractors and the percentage of works to be subcontracted to be submitted ~~online~~ through the ESPD as per Question Reference number 4C.10.

Note that the ESPD form is included in the tender documents package.

Tenderer's Technical Offer in response to specifications to be submitted ~~online~~ through the prescribed Tender Response Format and by using the Tender ~~Preparation Tool~~ forms provided.

Bidders are reminded that as per Instruction to Tenders: Prospective tenderers must submit their response to this tender in a sealed envelope by hand, at St Paul's Anglican Pro-Cathedral Valletta, by completing the prescribed tender response

format (Organisation and Methodology and Financial offer form). Bids submitted via email will be automatically disqualified. Two printed copies originally signed and a soft copy in readable pdf form on a CD or pen drive are to be submitted in the same sealed envelope.

3. Clarification sought:

- the Technical Offer (for tender phase) shall consist of a Detailed Method Statements referring to the Schedule of Tender Submittals that must be filled in, a Construction Management Plan, a Quality Plan, a Labour Histogram: is this correct?

Clarification reply:

Yes it is correct. They need to be provided as part of the bid.

4. Clarification sought:

Technical Questionnaire: where do I could find this document?

Clarification reply:

Clause 2. Technical Questionnaire as per form marked Technical Questionnaire is not applicable for this tender.

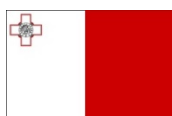
All other tender documents, conditions and requirements, which are not superseded by this clarification, remain in place.
