# 1. Clarification sought:

What is being expected in the Construction Management Plan (CMP)?

#### Clarification reply:

The CMP is to reflect all the Works and Methodologies described in the bidder's submitted documents. A preliminary outline of the CMP is included in the tender document Volume 6.06.

2. Clarification sought: Will the bells timber structure need to be removed?

#### Clarification reply:

The bells timber frame is to remain in place and be protected. The bells shall be lifted as is with their headstock, under the supervision of the appointed expert, and stored in the designated location for the duration of the works.

#### 3. Clarification sought:

Can the timber planks forming part of the platforms in the tower be removed to facilitate scaffolding erection?

#### Clarification reply:

The timber planks are historic and are not to be removed. These are to be protected as described in the tender document Volume 5, BOQ item B.13.6 and drawing C00667.00-S-020 and -021.

#### 4. Clarification sought:

Is there any additional information available regarding the metal cross at the top of the spire?

# **Clarification reply:**

There is no additional information available at this point concerning the metal cross.

# 5. Clarification sought:

Are execution (construction) drawings required at this stage?

# Clarification reply:

No construction drawings are required at this stage. Only preliminary documentation is being requested.
